Non-Resident Freeport Educators: Teachers who live out of town but who work in a Freeport school may get a courtesy non-resident card free of charge. The school must be located in Freeport and you must show proof of employment. Teacher cards are to be used by the teacher only. Courtesy cards have a limit of 5 interlibrary loans at a time and are not able to use FCL's Museum & Park passes. Proof of employment is required each year for renewal.

Freeport Community Library (FCL) is funded wholly by Freeport taxpayers. Freeport residents, property owners, employees of the Town of Freeport, and Freeport Educators are eligible for free library cards with proof of residence/ownership/employment. Residents of other towns may purchase an annual membership. Non-resident family cards cost \$60 per year, \$30 for 6 months, or \$15 for 3 months.

Freeport Community Library protects each library user's right to privacy, and confidentiality regardless of age or relationship to other library patrons. Maine Law (Title 27, Section 121) mandates confidentiality of information sought or received and resources consulted, borrowed, acquired or transmitted.

I understand that I am responsible for all items checked out on my library account and I will pay for any lost or damaged items; replacement copies are not accepted. Furthermore, I am aware that items more than 45 days overdue may be considered "lost" and that if an item has been designated as "lost" it is no longer eligible for return and replacement costs must be paid.
